#### **REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES:**

1. Knowledge of standard practices of one or more of the building crafts, including materials, tools and related procedures.
2. Knowledge of effective lead and supervisory techniques and practices.
3. Knowledge of the repair and maintenance of buildings, equipment and fixtures.
4. Knowledge of County construction codes and maintenance standards.
5. Knowledge of occupational safety and health standards applicable to assigned trade.
6. Ability to plan, organize and supervise the work of subordinates.
7. Ability to guide and instruct subordinates in preventive maintenance.
8. Ability to make accurate estimates of time and materials for maintenance projects.
9. Ability to read, interpret, and work from sketches, blueprints and specifications.
10. Ability to physically perform work assigned.
11. Ability to understand and follow oral and written directions.
12. Ability to establish and maintain productive working relationships with co-workers, superiors, and others.
13. Skill in the use of construction, repair and maintenance hand and power tools.
14. Skill in the safe operation of assigned light motor vehicles.

#### **MINIMUM TRAINING AND EXPERIENCE REQUIREMENTS:**
