Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Progress Report.

Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year and Annual Plan

1. Increase CCHRA Net Operating Income through actions aimed at increasing funding and decreasing operational costs.

INCREASING FUNDING. CCHRA continues to pursue initiatives to increase non-HUD related sources of funding. The beauty shop conversion project is being out for bid this month and we plan to begin the necessary renovation of the space in the first quarter of 2020. As mentioned previously, we project annual revenue of \$36,000 from this conversion. In addition, rent payments have been increased for the two current tenants on the top floor of Joseph Floyd Manor, and we continue to look for two additional tenants for available space there. Finally, CCHRA was successful in obtaining a commitment from Charleston County for \$300,000 annually to be utilized for upgrades to scattered site housing units.

DECREASING OPERATIONAL COSTS. CCHRA has aggressively pursued cost reduction measures in the past year, resulting in our reserves being built up from zero a year ago to an average of \$300,000-\$500,000 on a monthly basis. Each department is responsible for developing and administering a budget, and the CEO and CFO are holding weekly budget variance meetings with department heads to keep tight control over expenditures. Credit card usage is now restricted to the CEO/CFO and staff signature authority for purchases has been decreased to \$2000. A new purchase order system has been implemented to replace use of company credit cards. In addition, CCHRA has increased standardization of replacement equipment purchases such as refrigerators in order to achieve cost savings. Overtime has been virtually eliminated and other initiatives are being pursued to reduce operating costs.

2. Take necessary actions to improve all aspects of CCHRA staff and BOC operations.

(A) A major initiative to reorganize the maintenance function and better integrate with the three AMPS has been in the planning stages and is nearing implementation. Utilizing budget from unfilled senior management positions, a new Director of Asset Management position is being established and will soon be recruited. The position will report directly to the CEO and will have responsibility for oversight of the AMPS, including maintenance and public housing unit management. Also in the maintenance arena, a technical certification program at Trident Technical College for new maintenance staff hires is being implemented in order to better utilize the maintenance staff.

(B) The CEO will complete the ED Education Program in May and graduate in January 2020. Staff training and cross-training continues, particularly in the area of financial management.

(C) With respect to BOC operations, a Board Retreat was conducted in August to develop goals and objectives for FY 20-25 as well as to receive information of board governance from a HUD related expert.

3. Pursue initiatives aimed at building stronger relationships within the community, state, nation, and the housing authority.

We have developed stronger relationships with Charleston County, The City of Charleston, and the City Housing Authority and other organizations. Specifically,

- (A) As a result of the funding from Charleston County described above, the Director of Community Development, Ms. Jean Sullivan, has become more involved with CCHRA and frequently attends meetings and receives reports on utilization of county funding.
- (B) We are working with the City of Charleston, which has committed to purchase the Single Family Units (for which we are seeking disposition approval), for its new home ownership program. The Charleston area has experienced one of the largest increases in rent in the nation and the need for affordable housing has increased exponentially. Sale to the City will assure that the properties will remain affordable in perpetuity, producing wins for the City, for CCHRA, and for the community. In addition, the CEO has been recently invited to serve on the Charleston Mayor's Commission on Homelessness and Affordable Housing, which will elevate CCHRA's visibility in the community and enable us to be a better partner on finding affordable housing in the region.
- (C) the CEO is now on the Board of My Sisters House, which serves victims of domestic violence and has a focus on low income housing. As such he is able to network for the agency and seek out opportunities for partnerships and mission fulfillment.
- (D) The CEO has been recently invited to serve on the Charleston Mayor's Commission on Homelessness and Affordable Housing, which will elevate CCHRA's visibility in the community and enable us to be a better partner on finding affordable housing in the region.

4. Improve public relations and communications, both internal and external. See response to objective 3 above.

5. Take actions to improve quality of life for CCHRA residents.

- (A) Enhancements are being made to the interiors of public housing units, including new blinds in every unit at Joseph Floyd.
- (B) The following quality of life initiatives have been pursued for CCHRA residents: Health screenings were made available for all residents; two yards sales were held for Public Housing residents; a field trip was conducted to the Coastal Carolina Fair Senior Day; Thanksgiving Dinner and Christmas party were offered for all residents; Bingo nights are now being held
- (C) The Authority's FSS Program received an overall rating of Excellent from HUD, receiving the highest score in the state.

6. Expand housing opportunities for citizens served by CCHRA.

CCHRA's request for HUD approval to dispose of 18 scattered site housing units to generate revenue for redevelopment was decreased to 9 by the Board of Commissioners and has been submitted. We are awaiting approval for subsequent sale to the City of Charleston.

It is hoped that the actions discussed above with respect to stronger ties with the City and County will result in new initiatives to increase the supply of affordable housing in Charleston County.

A PHA that owns or operates fewer than two hundred fifty (250) public housing units, may lease a unit in a public housing development to an over-income family (a family whose annual income exceeds the limit for a low income family at the time of initial occupancy), if all the following conditions are satisfied: (1) There are no eligible low income families on the PHA waiting list or applying for public housing assistance when the unit is leased to an over-income family; (2) The PHA has publicized availability of the unit for rental to eligible low income families, including publishing public notice of such availability in a newspaper of general circulation in the jurisdiction at least thirty days before offering the unit to an over-income family; (3) The over-income family rents the unit on a month-to-month basis for a rent that is not less than the PHA's cost to operate the unit; (4) The lease to the over-income family provides that the family agrees to vacate the unit when needed for rental to an eligible family; and (5) The PHA gives the over-income family at least thirty days notice to vacate the unit when the unit is needed for rental to an eligible family. The PHA may incorporate information on occupancy by over-income families into its PHA Plan statement of deconcentration and other policies that govern eligibility, selection, and admissions. Occupancy by Police Officers. The PHA may allow police officers who would not otherwise be eligible for occupancy in public housing, to reside in a public housing dwelling unit. The PHA must include the number and location of the units to be occupied by police officers, and the terms and conditions of their tenancies; and a statement that such occupancy is needed to increase security for public housing residents. A "police officer" means a person determined by the PHA to be, during the period of residence of that person in public housing, employed on a full-time basis as a duly licensed professional police officer by a Federal, State or local government or by any agency of these governments. An officer of an accredited police force of a housing agency may qualify. The PHA may incorporate information on occupancy by police officers into its PHA Plan statement of deconcentration and other policies that govern eligibility, selection, and admissions. Non-Smoking Policies. The PHA may implement non-smoking policies in its public housing program and incorporate this into its PHA Plan statement of operation and management and the rules and standards that will apply to its projects. See additional guidance on HUD's website at: [Notice PIH 2009-21](#). (24 CFR §903.7(e))

Project-Based Vouchers. B.6 Resident Advisory Board (RAB) comments. If the RAB provided comments to the annual plan, mark "yes," submit the comments as an attachment to the Plan and describe the analysis of the comments and the PHA's decision made on these recommendations. (24 CFR §903.13(c), 24 CFR §903.19)

B.7 Certification by State of Local Officials. Form HUD-50077-SL, *Certification by State or Local Officials of PHA Plans Consistency with the Consolidated Plan*, must be submitted by the PHA as an electronic attachment to the PHA Plan. (24 CFR §903.15). Note: A PHA may request to change its fiscal year to better coordinate its planning with planning done under the Consolidated Plan process by State or local officials as applicable.

B.8 Troubled PHA. If the PHA is designated troubled, and has a current MOA, improvement plan, or recovery plan in place, mark "yes," and describe that plan. If the PHA is troubled, but does not have any of these items, mark "no." If the PHA is not troubled, mark "N/A." (24 CFR §903.9)

C. Statement of Capital Improvements. PHAs that receive funding from the Capital Fund Program (CFP) must complete this section. (24 CFR 903.7 (g))

C.1 Capital Improvements. In order to comply with this requirement, the PHA must reference the most recent HUD approved Capital Fund 5 Year Action Plan.
